Inspection of Mares and Foals

June 22, 2008 – Shannondale Farm, Alpharetta GA

Please complete this form and return by **June 1**. Late entries will incur a \$25.00 late fee. Mail completed forms, along with check for fees shown below to **Chris Hutchings, 3345 Hopewell Chase Drive, Alpharetta GA 30004**. Please make checks payable to Shannondale Farm. Inspection/registration fees will be assessed separately at the inspection by the Oldenburg Horse Breeders' Society (see the enclosed fee schedule). Braiding and Handling fees are payable at the inspection to the service providers.

Include the following with your entry:

- Mares being presented for breeding approval: Photocopy of foal registration papers w/pedigree. (Bring the ORIGINAL to the inspection, including official pedigree).
- Foals: Photocopy of Breeding Certificate signed by the stallion owner and inseminating veterinarian. (Bring the ORIGINAL Breeding Certificate for the foal to the inspection.)
- Weaned foals and all horses over 6 months of age: Proof of CURRENT negative Coggins test. Current Health Certificate (within past 6 months) also required if coming from out of state.

PLEASE NOTE: Stabling is limited and will be reserved on a first-come, first-served basis. Payment must accompany entry to reserve stabling. Stabling fees are assessed as follows: 3 PM Saturday thru 3 PM Sunday – \$80/stall (incl. initial shavings); 8 AM Sunday thru 3 PM Sunday – \$45/stall (incl. initial shavings).

Fees will be refunded only if cancellation notice is received by the organizer before 5 PM, June 15. Please direct questions to Chris Hutchings at 404-630-9133 or via email to chutchings@mindspring.com.
